# BUDGET MOTIVATION BY THE HONOURABLE LEON JOOSTE, MP, MINISTER OF PUBLIC ENTERPRISES

**VOTE 34** 

NATIONAL ASSEMBLY, 08 JUNE 2020

#### Honorable Chairperson of the Whole House Committee and Honorable Members,

- I rise to present a short motivation for the budget Vote 34 of the Ministry of Public Enterprises.
- Please allow me, Honorable Chairperson, to congratulate the Honorable Minister of Finance and Director General of Economic Planning for the preparation of the FY 2020/21 Budget and Medium- Term Expenditure Framework under these difficult conditions.
- His Excellency the President's State of the Nation Address, under the theme **Year of Introspection**, has set the tone. In the SONA, His Excellency highlighted the current situation nationally and globally, such as a high fiscal deficit, poor economic growth, protracted drought, global economic downturn and the infamous COVID-19 pandemic, which all impact Public Enterprises financially and operationally.
- Honorable members, with the operationalization of the Public Enterprises Governance Act No1. of 2019, the Ministry of Public Enterprises assumed a new mandate which translated into taking responsibility for the portfolio of Commercial Public Enterprises (CPE).
- I would therefore like to provide this August house with a snapshot of the state of the Commercial Public Enterprises our Ministry is taking over , so that Honorable members can appreciate the difficult task that is placed on us not only as a Ministry but as a nation, that is of transforming these entities and turning them into key positive net contributors to the growth of our economy.
- Honorable Members, our ministry is taking over a portfolio of twenty-two (22) CPEs, with a total asset value of N\$70,2 billion and liabilities of N\$33,2 billion giving a portfolio net asset value of N\$37 billion and a debt/asset value of 47,3%. Overall revenue has grown by 1,9% year-on-year (2018 2019) while the expenditure growth rate has grown to 12,6% over the same period translating into a total profit of N\$1,7 billion for the entire portfolio and a profit margin of 7,4%.
- Considering the stark reality of our current economic situation, I believe that it is now more critical than ever to expedite the reform

of our Public Enterprises and for them to become economic enablers in our country without them being a burden on Treasury.

May I now move, Honorable Chairperson that this August House considers the total budget allocation to the Ministry of Public Enterprises, for the financial year 2020/2021, which amounts to N\$ 1, 409, 496, 000. (One Billion Four Hundred and Nine Million Four Hundred and Ninety-Six Thousand Namibian Dollars).

This budget figure consists two parts, namely:

 N\$ 38, 195, 000 for the execution of the Ministry's activities; and N\$ 1, 371, 301, 000 for the support to Commercial Public Enterprises

#### Honorable Chairperson,

The activities of the Ministry of Public Enterprises are grouped under two main Programmes; namely:

- 1. Legal, Economic and Financial Advisory Services; and
- 2. Policy Coordination and Support Services.

#### <u>Programme 1: Legal, Economic and Financial Advisory</u> <u>Services:</u>

An amount of **N\$ 12, 209, 000 (Twelve Million Two Hundred and Nine Thousand Namibian Dollars)** has been allocated to this Programme to enable the Ministry carry out its functions

#### **Programme 2: Policy Coordination and Support Services:**

An amount of N\$25, 986, 000 (Twenty-Five Million Nine Hundred and Eighty- Six Thousand Namibian Dollars) allocated to this programme is earmarked to enable the Ministry carry out its operational activities. The total amount of N\$1, 371, 301, 000 (One Billion Three Hundred and Seventy-One Million Three Hundred and One Thousand Namibian Dollars) is allocated as subsidies to the Commercial Public Enterprises which require government financial support.
